

Selling with Equine Saddle Fit

<u>The Service</u> – Equine Saddle Fit offers a Sale on Behalf service for all saddles of in good condition that of well-known brands, up to 18.5 inch, and most widths, we reserve the right to decide whether to take a particular model.

The Benefits to You Once accepted by us for sale on your behalf, we will advertise your saddle on our website and Facebook page, and make it available for all clients' saddle fitting appointments where it is suitable to that client's needs. The additional benefits to you of this service are that our clients all become potential buyers for you and they are able to try the saddle with expert advice available, meaning they won't discount your saddle when a simple packing adjustment is all that is needed to achieve a good fit. We also will send the saddle on 7 day trial with full payment made and held by us until returned or sold. Buyers will also have the confidence of our warranty (see below) and aftersales service, meaning that you can ask a higher price for your saddle than you may be able to privately.

Pricing We will advise you on what we consider the market value of your saddle, however the ultimate decision on pricing is yours. If your saddle has not sold after three months and we consider the reason to be that the price is too high then we will advise that you reduce the advertised price. If you do not wish to take our advice at this point then we will return the saddle to you at your cost

Sale on Behalf Rates

Outright Purchase

Please Note

We do not accept any saddle that is damaged in a manner to which it has become structurally compromised in any way. This includes but is not limited to: broken or compromised trees, damaged stirrup bars or substantial damage to any area of the saddle. Saddles sent to us for sale that we deem to be fundamentally compromised will be returned at the cost of the owner and not offered for sale by us.

Saddles that require small repairs or maintenance such as: re flocking, new girth points or other similar work can be sent to us for resale. Any repairs, flocking or other work will be charged at competitive rates and due for payment prior to advertising the saddle.

Saddles listed for Sale On Behalf with Equine Saddle Fit will be exclusive to us for the first 3 months of being offered for sale.

You agree to give all true details to Equine saddle fit about the saddle

That the saddle you are selling is YOUR property – Equine saddle fit will take no responsibility for any problems regarding false ownership of the saddle.

Consumer Guarantees Act & Warranty

When we sell a saddle on your behalf, the sale contract is between Equine Saddle Fit & the purchaser. This means that the sale comes under the Consumer Guarantees Act and as such we must warranty the saddle and provide after sales service. We must therefore be confident that the saddle is free of defects including the tree, stitching, leather, etc. We offer a six-month warranty on all used saddles as such
